THIS AGREEMENT is made on this ____ day of _____, 20__ By and between _____, hereinafter referred to as the "adopter" and Rocking Double H Paso Fino Horses hereinafter referred to as "the Organization". Adopter agrees to pay the adoption fee of \$_____.

1. Adopter understands and agrees that the equine identified in this contract may not be sold, given away, lent, leased, removed from Adopter's personal supervision and control, or removed from the address described herein, except for emergencies, shows, trail rides and other temporary situations without written approval of the

Organization. Should the equine not be at the location as stated herein upon inspection by the Organization representative, Adopter will immediately relinquish any rights or interest Adopter may have in the equine and the Organization will immediately take possession of the equine.

2. Adopter agrees to meet the Organizations standards of care for said equine, maintaining good nutritional health, vet care, vaccinations, worming, dental care and hoof care. Adopter Agrees to provide the Organization copy of a veterinary examination and proper vaccinations records for adopted horse/horses once a year. Adopter must provide good fencing, water, proper pasture, and shelter for adopted horse at all times.
3. Should the Adopter decide that the equine is no longer wanted for any reason, Adopter understands the Organization must be notified and that the equine will be returned to the Organization if qualified Adopter is not found. The Organization will assist Adopter 1 in finding a home that fulfills the qualifications of the Organization. The horse will again be adopted out on the Organizations contract. Adopter 1 agrees to donate 10% of monies paid by adopter 2 to the Organization. If another adopter cannot be found, the Organization will take possession of the horse. Adopter understands and agrees that the adoption fee is non-refundable.
4. Adopter agrees that an authorized representative of the Organization may enter the property where the said equine resides during normal business hours, 24 hours notice, to determine if all conditions of this adoption contract are being complied with completely. Adopter understands that should a violation of adoption agreement be found, whereby such conditions represent danger to the health and welfare of the equine, said equine may be removed immediately provided two or more members of the board of directors agree that immediate removal is in the equines best interest. Furthermore, if said equine cannot be removed immediately, adopter hereby authorizes a representative of the Organization to enter property at anytime, without cause or warrant, where equine resides and take immediate physical possession of said equine without any recourse by adopter.
5. Adopter further agrees that, he/she will accept all responsibility for any action or lien resulting from any action, directly or indirectly, involving said equine while it is in Adopter's possession and under Adopter's care and control. If equine is stabled other than at adopter's residence, adopter must notify owner/manager of facility that the equine may not be held as collateral for any charges incurred by adopter. Therefore, Adopter agrees and understands that neither the Organization nor its employees or agents will be liable for any damages or injury caused to Adopter or any third person by the equine once Adopter receives delivery of the equine, including but not limited to damages or injuries caused by the fact that the equine does not behave or perform in the manner Adopter expected. Further, if any third person makes a claim against the Organization or any of its employees or agents as a result of any conduct of the equine after Adopter has taken possession of the equine, Adopter agrees to indemnify and hold the Organization, its employees and agent harmless from any such claims, including costs and attorney's fee resulting from such claim.
6. Adopter agrees never to breed the above-described equine for the duration of the equines life. If the equine is bred, the Organization must be informed immediately. The Organization reserves the right to remove equine from adopter at this time. However, if organization decides to let adopter keep the equine, the resulting offspring of the equine automatically becomes the property of the Organization and must be returned to the Organization once it is old enough to be weaned with a \$500 donation to the Organization.
7. Adopter may personally return the equine to the organization or Adopter may arrange for their return to the Organization by an authorized representative of the Organization if Adopter so desires at any time during the equines life. In the event of the Adopters death, and if Adopters heirs are unable or unwilling to maintain the equine, Adopters heirs must also return the equine to the Organization as provided for above. Upon death of the equine, a licensed veterinarian must confirm the death and provide a statement to the best of their knowledge the cause of death and adopter must provide a copy of statement to the organization within 30days of death of equine.

In the event the undersigned fails to comply with the terms of the Application and Agreement, the Organization reserves the right to commence legal proceedings to recover the horse and the undersigned shall be liable for all costs including damages to the Organization at a minimum of \$5,000.00, to include reasonable attorney's fees, in connection with such legal proceeding.
